As I approach my departure from the Ohio to Erie Trail as the Executive Director, I look back at the past ten years with a feeling of great accomplishment. Ed Honton was the founder of the Ohio to Erie Trail, and it was humbling to attempt to continue the work he began. He mentored me in 2004 as he battled cancer so that the Trail would be completed.

The mission to build a trail from Cincinnati on the Ohio River to Cleveland on Lake Erie remains crystal clear, and that is what I strived to help our Board accomplish each day.

I learned quickly that it takes three things to build such a trail: a committed group of trail supporters, the trail right-of-way and money. Most people assume that money is the most important factor, but nothing happens without a group committed to completion of the Trail.

Working with Ohio to Erie Trail Board and our supporters has been enormously rewarding. I am not leaving entirely for I will become a member of the OTET Board in January.

I thank everyone for the opportunity to help continue the growth of the Ohio to Erie Trail across this great state.

JULIE VAN WINKLE will assume Rampelt's duties as Executive Coordinator for the Ohio to Erie Trail. She will work as the spokesperson and manage the affairs of the OTET at the direction of the Board of Directors. It is well

Ohio to Erie Trail Strategic Planning Retreat

The Board of the Ohio to Erie Trail held a retreat on August 9, 2014 and created a strategic plan to guide the Board over the next four years. The previous 2010 plan provided a clear direction toward completion of the Ohio to Erie Trail. Zoe Klopf Switzer facilitated the full day retreat, and the outcome was the creation of these strategic goals and action plans.

- Hold a conference with trail managers and other stakeholders
- Update the website to meet the needs of our trail visitors
- Evaluate and improve our marketing and branding of the Ohio to Erie Trail
- Focus our efforts on trail completion projects
- Address trail maintenance and upkeep issues with our constituents



ODNR Awards 27% of Clean Ohio Funds to Ohio to Erie Trail Projects

In October 2014 The Ohio Department of Natural Resources awarded three grants to trail projects along the Ohio to Erie Trail.

- Cuyahoga County Department of Public Works was awarded \$500,000 for Stage 3 of the Towpath Trail, and the total project costs \$1,621,862.
- Preservation Parks of Delaware County was awarded \$566,858 for paving the Success Acres Trail off Meredith State Road. It will connect with the Heart of Ohio Trail in Knox County as part of the Ohio to Erie Trail. This 1.6 mile addition is in a rural and wooded area of eastern Delaware County.
- City of Orrville in Wayne County was awarded \$416,831 to construct the trail across the city limits as well as trailhead facilities as part of the Ohio to Erie Trail.

Friend of The Ohio to Erie Trail Award

OTET Board members Sam Speck and Bill Baker along with Director John O'Meara of Franklin County Metro Parks were named Friends of the Ohio to Erie Trail. Bill and Sam received their awards at the November 5 board meeting and John O'Meara received his at the Metro Parks board meeting on November 12. The newly created award will be given to individuals and organizations who have made a significant contribution toward completion of the Ohio to Erie Trail.

Alum Creek Trail Update

Thanks to the Columbus City Council the route of the Ohio to Erie Trail through Columbus will soon be connected as it was originally planned. Council voted in July to approve the money needed to construct the final two linkages.

The Ohio to Erie route currently utilizes sections

of road from Westerville to the Olentangy Bike Path. The Alum Creek Trail sections will be finished in 2015 so users will enjoy a continuous paved trail from Westerville to the Downtown Columbus connector and beyond. Watch our website in the spring for updates.



Cincinnati Area Trail News

Decisions have been made in Cincinnati which will further the Trail development from Downtown to Lunken Airport to the east. Cincinnati City Council voted this fall to convert part of the Oasis Light Rail Line into a trail for the 4 miles to connect to Lunken Airport. While this is a major development, it will still take several years for all

approvals and for construction to take place.

In addition, the section from Lunken Airport to Newtown will see an extension in the next year, under the management of Great Parks of Hamilton County. Still, additional funding will be needed for a bridge to be built over the Little Miami River to complete this connection.



OTET Quarter Century Mark Is on the Horizon

The 25th year of the Ohio to Erie Trail will be upon us as we conclude 2015.

Ed Honton was the spirit behind the concept and birth of the Ohio to Erie Trail in 1991. With the input of Tom Barlow (first GOBA Director) and Ann Gerckens (Columbus Outdoor Pursuits) Ed Honton began the quest to create the Trail.

As we approach our 25th year, we are grateful for the support of many generous benefactors who have given of their money, time and talents to overcome many challenges in land acquisition, funding sources, trail construction and signage, operation and maintenance.

Thanks to all of them, we are proud to celebrate that the Trail is more than 80% complete. It is now possible to traverse the entire route from end to end, as documented in our trail map published in late 2013. The goal continues to be the accomplishment of a fully connected off road trail system.

Over the next two years, trail projects across the state will bring us at least 36 miles closer to our target. Please watch our website, Facebook page and newsletters, as we recognize the contributors and celebrate our approaching 25th anniversary.


Maps of The Ohio to Erie Trail!



Seeking Sponsors To Update Ohio To Erie Trail Maps

We need sponsors to help with the costs of an updated version of the printed map. Over 19,000 OTET maps

were distributed in 2014 including 1,100 maps mailed to people who ordered online for a handling and postage



fee. There are fewer than 1,000 maps in stock and the reprint is needed before the spring of 2015. Since new sections of trail are being paved each year the updates have become an important and necessary task to keep the information as current as possible.

Major sponsors for the 2014 map were American Electric Power, the Ohio Department of Transportation and the Ohio Department of Natural Resources.

Large and small donations will help tremendously. A \$5,000 donation will entitle you to a major sponsorship for the 2015 map.

The Ohio To Erie Trail maps are printed on four sheets of paper that are 8 1/4 X 25 1/2 and folded to make six panels. All four sheets are in a custom envelope making a neat and easy to use navigation kit. The maps have been designed to provide straightforward, user-friendly information with mileage and a written descriptions.
